Under minimum supervision, repairs and maintain machinery, mechanical equipment and devices. Such as motors, conveyor systems, gear boxes, chains, sprockets and production equipment in accordance with diagrams, sketches, operation manuals, blue prints and manufacturer's specifications.

Essential Functions include:

- A. Responsible for adherence to company policies including safety and the use of personal protective equipment.
- B. Performs functions of the Mechanic role.
- C. Observes mechanical devices in operation and listen to their sounds to locate causes of trouble and starts devices to test their performance.
- D. Regular and predictable attendance is essential in this role.
- E. Dismantles equipment to gain access to and remove defective parts.
- F. Examines form and texture of parts to detect imperfections.
- G. Inspects used parts to determine changes in dimensional requirements.
- H. Repairs or replaces defective parts. Installs special functional and structural parts in devices.
- I. May direct the maintenance helper and others in performing duties. May train less experienced maintenance personnel.
- J. Provides assistance lubricating and cleaning parts when needed.

Mental and Physical Requirements

Ability to use a wide range of precision measuring instruments, such as scale, squares, micrometers, calipers, indicators, hand tools and power tools. Ability to work independently and as part of a team. Ability to drive fork lift with proper license. Ability to perform arc welding, MIG, TIG and flame cutting and grinding. Ability to read and write English is necessary to be success in this position.

The mechanic performs in a warehouse and factory environment. While performing the duties of this job, the mechanic is regularly required to stand; walk; use hands to finger, handle, or feel and reach with hands and arms. The mechanic will occasionally be required to sit; climb or balance; stoop, kneel, crouch, or crawl and talk or hear. Regularly required to lift and/or move at least 75 pounds. Occasionally required to lift and/or move up to 100 pounds.

The mechanic is regularly exposed to moving mechanical parts, extreme hot and cold temperatures, and loud noises. Occasionally exposed to high, precarious places; fumes or airborne particles; outside weather conditions; risk of electrical shock and vibration. May be required to differentiate colors and shades of colors. Specific vision abilities required by this job include distance vision and depth perception. The mechanic may be required to work outside of normal business hours.
