Programming and operational use of Allen Bradley, CTI, Simotion, Direct Logic PLC's, AC/DC variable speed drives and servo drives.

Essential Functions include:

- C. Diagnoses and isolates production equipment malfunctions using schematics, wiring diagrams, blue prints and associated test equipment.

- E. Constructs new and modifies existing installations as per NEC.
